### **Welcome to Vista View Flyers & Drivers Club!**

Vista View RC is a Remote Control Club formed to fly gliders, electric airplanes, electric helicopters, multi-rotors and drive electric vehicles and boats at Vista View Park. No internal combustion engines allowed! We are an official chartered club of the Academy of Model Aeronautics (AMA) and Remotely Operated Auto Racers (ROAR). You must have a current membership with Vista View RC and a current AMA Open Membership/ROAR membership to fly/drive at this park. Club and Park officials will not allow you to fly without your membership! Permission to use RC was granted by Broward County Parks on May 2006.

Some of the Vista View RC club benefits are:

- We provide the county mandated, \$4 Million Dollar liability insurance policy supplementing your \$2.5 Million Dollar AMA liability coverage for flight and \$1 Million Dollars for the Car Track and Boats.
- Free instruction provided for pilots/drivers of all skill levels at designated times. We have AMA endorsed instructors on staff and have club owned beginner airplanes/cars available for lessons to get you started (by appointment, Saturdays and Sundays 8AM - 10AM).
- Multiple yearly, family friendly, fun-fly/drive and night-fly/drive events with free food for members, families and a guest as well as a free raffle ticket to the members only raffle. Our event raffles (members-only and public) are some of the most spectacular at any fun-fly/drive events around. The most fun you will have at any RC event!
- At Vista View RC, besides our Safety Officers and Vista View Park staff, we encourage every member to take the role of a safety officer. Make this a safe and enjoyable RC experience for everyone!

# **Please Read, Vista View RC Club Rules**

The Broward County Parks Department and Vista View RC Club jointly welcome you to the Vista View Park flying site. RC at Vista View Park is granted by the Broward County Board of Commissioners subject to Compliance with the official AMA/ROAR safety code and the Broward County Parks safety rules, regulations, posted signs and AMA and ROAR rules which have been adopted by Vista View RC.

1. You must apply and receive a Vista View RC membership to practice RC activities at those Vista View Park RC areas per our contract with the county and our insurance agreement. These RC areas are privately funded, maintained and overseen with the cooperation of the park staff.
2. Before practicing RC at the designated areas all members must have the Comprehensive General Liability Insurance Coverage provided by the AMA or ROAR. A current valid Open AMA membership card or ROAR card needs to be presented for membership. Park flyer AMA cards will not be accepted. AMA cards cover flying, driving cars and boats whereas ROAR cards cover only driving cars, no flying or boats.
3. The official AMA and ROAR safety codes, Vista View Park rules and Vista View RC Club rules are in effect at all times when practicing RC at Vista View Park.
4. You must wear your Vista View RC Membership ID in a visible location at all times when practicing RC at the Vista View RC areas.
5. All 72MHz and 27MHz flight and 5.8GHz FPV frequencies are obtained by the member placing a frequency reservation card or your AMA card in the proper slot on the frequency control board. All 72MHz and 27MHz transmitters must display a frequency channel flag as per AMA guidelines. If you fly 2.4GHz you don't need to post anything on the frequency board but you still need to wear your Vista View RC Membership ID. Only 2.4GHz transmitters are allowed at the car track or in the boat area.
6. All RC at Vista View Park must be silent powered. Examples of these are electric aircraft and cars as well as assisted and unassisted gliders. No internal combustion engine powered RC vehicles are allowed.
7. A maximum of sixteen aircraft are allowed to be airborne at any one time. Five of these can be powered aircraft flown in the designated power aircraft area. Three of these can be gliders flown in the designated glider area. Three of these can be helicopters or multi-rotors flown in the designated west helicopter/multi-rotor area. Five of these can be helicopters or multi-rotors flown in the designated east helicopter/multi-rotor area. For details on the designated flying zone please consult the map posted on the bulletin board at the flying site.
8. Deliberate flying behind the safety line is prohibited. No live RC is allowed in the pit areas.
9. Direction of flight is determined by the wind direction.
10. RC operations will stop during electrical storms.
11. Pilots must fly from the flight line pads except during take-offs and landings. No one should be forward of the flight line unless they have take-off or landing clearance. Unless special clearance is given only one pilot may take-off or land at one time. Landing aircraft have runway right-of-way. Dead stick landings have first priority. Pilots must announce their intentions to establish clearance and enter the fly zone (pilots shall make appropriate announcement when taking off, landing, or emergency situations).
12. Spectators are not permitted in the flying and driving zones; only pilots, drivers, spotters and designated pit crew.
13. At the RC car track, car track marshals have the right of way. Announce any time you are entering or exiting the track.
14. All posted regulations must be observed.
15. Keep the area clean of all trash and debris.
16. No alcohol is permitted.
17. No planes or cars are to be worked on while sitting at the picnic tables, please use the work tables.
18. Common sense will apply at all times. Safety, being paramount, is everyone's responsibility.
19. Be aware that Vista View Park is a multi-purpose park. At times horses, pedestrians and para-gliders may enter our RC areas. If this were to happen stay high or land immediately; whichever is safest, at the car track, stop driving. Please communicate in a courteous manner with non members entering the RC areas and ask them to stay clear. If they do not cooperate then involve a Club Officer or call a Park Ranger (the number is on the back of your membership card).
20. No aggressive action towards an individual or individuals (physical or verbal, deliberate destruction of other peoples property, etc.) will be tolerated. This will result in immediate loss of all flying privileges and being asked to leave the park permanently.
21. The above rules are additions to the Vista View Park General Rules. All rules of the RC areas and Vista View Park are to be observed while at the RC fields. Any violations of these safety regulations can subject the offender to removal from the RC areas and from the park. Vista View RC Officers and Park Rangers have the right to deny anyone the right to practice RC if they deem any rules are being violated, please respect this authority.
